Modificarea Procedurii de implementare a măsurii "Granturi pentru capital de lucru acordate IMM-urilor"

În Monitorul Oficial nr. 335 a fost publicat Ordinul nr. 218/2021 privind modificarea Procedurii de implementare a măsurii "Granturi pentru capital de lucru acordate IMM-urilor" din cadrul schemei de ajutor de stat, în contextul crizei provocate de COVID-19.

Bugetul alocat măsurii "Granturi pentru capital de lucru acordate IMM-urilor", " din cadrul schemei de ajutor de stat instituite prin OUG nr. 130/2020 privind unele măsuri pentru acordarea de sprijin financiar din fonduri externe nerambursabile, aferente Programului operațional Competitivitate 2014-2020, precum și alte măsuri în domeniul fondurilor europene, aprobată prin Ordinul nr. 3.083/2020, a fost modificat și are o valoare totală de 626.292.610,44 euro, din care:

- 470.720.436,80 euro fonduri externe nerambursabile,
- 73.881.833,15 euro fonduri de la bugetul de stat și coparticipare (cofinanțare) de 81.690.340,49 euro de la beneficiari.

Termenul de soluționare a contestațiilor a fost mărit de la 3 zile la 30 de zile de la data primirii contestației.

Amendments to Procedure for implementing the measure "Grants for working capital granted to SMEs"

Order no. 218/2021 on amending the Procedure for implementing the measure "Grants for working capital granted to SMEs" within the state aid scheme, in the context of the crisis caused by COVID-19, was published in Official Gazette no 335.

The budget allocated for the measure "Grants for working capital granted to SMEs", established by GEO no. 130/2020 on some measures for granting financial support from non-reimbursable external funds, related to the Operational Program Competitiveness 2014-2020, as well as other measures in the field of European funds, approved by Order no. 3,083 / 2020, was modified and it has a total value of EUR 626,292,610.44, of which:

- EUR 470,720,436.80 of non-reimbursable external funds,
- EUR 73,881,833.15 from the state budget and co-participation (co-financing) of EUR 81,690,340.49 from the beneficiaries.

The term for solving the appeals was increased from 3 days to 30 days from the date of receiving the appeal.
