

- Order no. 675/2021 for the amendment and completion of the Financing Guide of the Program on the reduction of greenhouse gas emissions in transport, by promoting clean and energy efficient road transport vehicles, 2020-2024, approved by Order no. 323/2020 was published in the Official Gazette no. 432.
- Order no. 676/2021 for the amendment and completion of the Financing Guide of the Program for stimulating the renewal of the National Car Park 2020-2024, approved by the Order no. 324/2020 was published in the Official Gazette no. 433.
