

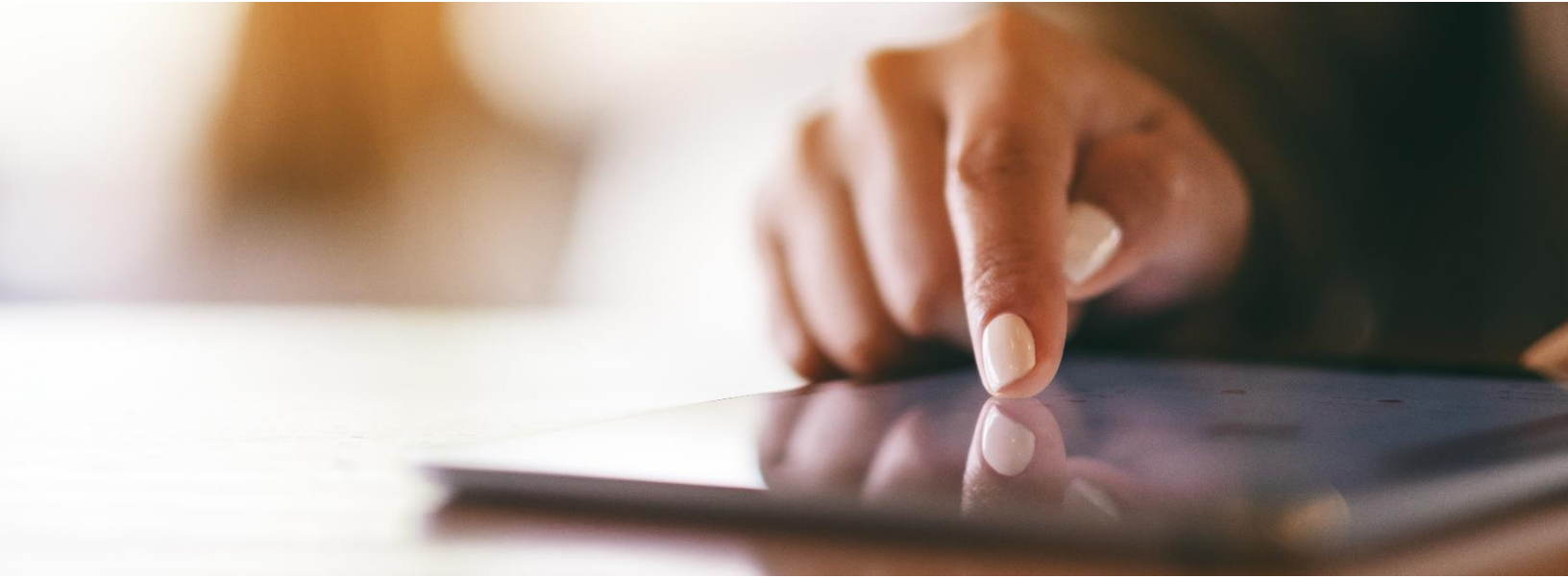

News regarding the procedure for granting the VAT customs deferment certificate

The Order no. 2045/2023 of the Minister of Public Finance amending the norms related to the procedure for granting the VAT customs deferment certificate and issuing the guarantee for imports of goods was published in the Official Gazette No. 829 on the 14th of September.

Main changes:

- The VAT certificate will be issued by the Romanian Customs Authority instead of General Directorate for Customs.
- Such certificate is valid for 6 months.
- The certificates issued before 14th September 2023 remain valid until 31.12.2023 or until the expiry date, whichever occurs first.
- The template application form for issuing the certificate has been updated.

Date entering into force: 14th of September 2023

Modificări la Normele privind procedura de acordare a certificatului de amânare a plății TVA în vamă

Ordinul nr. 2045/2023 al Ministrului Finanțelor Publice pentru modificarea Normelor privind procedura de acordare a certificatului de amânare a plății TVA în vamă și de eliberare a garanției pentru importurile de bunuri a fost publicată în Monitorul Oficial nr. 829 pe data de 14 septembrie.

Principalele modificări:

- Certificatul de TVA va fi eliberat de Autoritatea Vamală Română în locul Direcției Generale a Vămilelor.
- Acest certificat este valabil 6 luni.
- Certificatele emise înainte de 14 septembrie 2023 rămân valabile până la 31.12.2023 sau până la data expirării, în funcție de care dintre acestea survine prima.
- Modelul formularului de cerere pentru eliberarea certificatului a fost actualizat.

Data intrării în vigoare: 14 Septembrie 2023
